## Virgin Atlantic Flying Club offers BA Executive Club status match

Virgin Atlantic Flying Club has announced a new status match promotion with British Airways' Executive Club, enabling members to reach Silver or Gold status with just one flight booking.

To be eligible, members must make a new cash or reward flight booking by February 28, 2021, or have an existing booking for a future flight .

They can then head to [virg.in/statusmatch](http://virg.in/statusmatch), to provide proof of their current British Airways status and a booking reference for their upcoming Virgin Atlantic flight.

## **Covid 19 testing for UK arrivals**

All international arrivals into England will be required to provide evidence of a negative Covid-19 test result taken up to 72 hours prior to departure. The move will come into effect from 4am on Friday the 15th, and will apply to anyone seeking to travel to England by air, sea or rail.

All passengers arriving from countries not on the government's travel corridor list will still be required to self-isolate for 10 days, regardless of test result and still need to fill out a passenger locator form on arrival. Passengers will be subject to an immediate fine of £500 if they fail to comply with the new regulations on pre-departure testing.

There will be a limited number of exemptions, including for hauliers, children under 11, crews and for those who travelling from countries without the infrastructure available to deliver the tests. Further exemptions will be set out on GOV.UK.

## COVID-19 Travel restriction Map

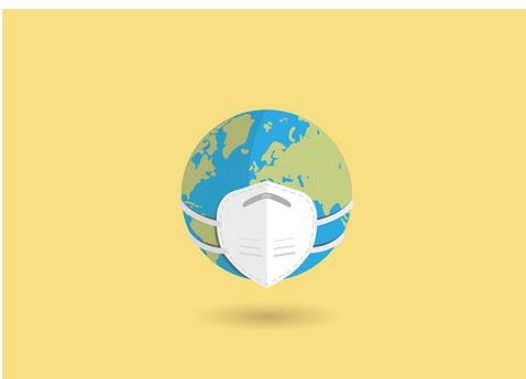
